I By signing and submission of this Bid to PLINACRO Ltd., the Bidder:

- a) fully accepts and agrees to the implementation of OS Rules, including all appendices thereto, particularly but not exclusively, to the implementation of provisions of Gas Transmission Contract form concluded on the basis of the Open Season procedure, contained in the Annex no. 2 of OS Rules, and
- b) confirms that it is fully acquainted with and accepts the implementation of legal regulations in the Republic of Croatia regulating the energy sector, the Network Code of the Transmission System, General terms of use of the transmission service at an interconnection, General terms of use of the transmission system and other regulations and acts regulating the gas market, and
- c) accepts and confirms that the submitted Bid is binding and irrevocable,
- d) confirms that the submitted Bid is valid and binds the Bidder according to OS Rules,
- e) accepts that the Croatian law is governing for the Bid, and any disputes arising regarding the Bid shall be within the competence of the court having in rem jurisdiction in Zagreb, and
- f) undertakes that, if Plinacro allocates the capacity to it, pursuant to the OS Rules, it will sign the Gas Transmission Contract form concluded on the basis of the Open Season procedure submitted by Plinacro and deliver to Plinacro a payment security instrument, all in compliance with OS Rules.

II The Bid shall be signed by authorised persons of the Bidder's company. A properly signed Bid form shall be submitted to PLINACRO Ltd. via mail or a courier service to the address indicted below in this form.
